

## Safety instructions for return of contaminated vacuum equipment and components

### GENERAL INFORMATION

CreaTec is responsible for the health and safety of its employees. This also applies to personnel from maintenance and/or repair of equipment and components. Any possible contamination of equipment and components must be specified on the following *Declaration for Return of Goods* together with the items to be repaired.

### DECLARATION OF CONTAMINATION

Any personnel from maintenance and repair has to be aware about the condition of the equipment and components before the initial work. This is the purpose of the „*Declaration for Return of Goods*“. The declaration must be sent directly to CreaTec and a second copy has to be attached to the dispatch papers outside of the packaging. **Consignments without the „*Declaration for Return of Goods*“ will not be handled.**

### SHIPMENT

Please note the following instructions when you return the goods to CreaTec:

- ▶ Add the *Declaration for Return of Goods*
- ▶ If necessary, shipping as „Dangereous Good“ with labels
- ▶ Drain all service fluids
- ▶ Neutralized pumps by rising with gas
- ▶ Remove filter elements
- ▶ Seal all openings airtight
- ▶ Shrink-wrap appropriately
- ▶ Ship in appropriate containers for transport (for effusion cells please use always the original outer- and inner carton including foam)
- ▶ Note the return number readable outside the carton and on the delivery note
